### Apr 27

Xi signed orders authorizing the revised Surveying and Mapping Law and appointing a new head of the National Audit Office.

Outcomes of the bimonthly NPC Standing Committee meeting, which concluded Thursday. Revised Surveying and Mapping Law will take effect on July 1, 2017. Hu Zejun will be new NAO head.

### Apr 25

### Xi chaired a Politburo meeting.

Analyzed Q1 economic performance and deliberated a report on inspections of politics and law (zhengfa) organizations.

## Xi chaired a Politburo Study Session.

Xi called for concrete efforts to maintain China's financial security, noting that financial security is an important part of national security, and a key foundation of the stable and healthy development of the economy. PBOC Governor Zhou Xiaochuan, CBRC Chairman Guo Shuqing, CSRC Chairman Liu Shiyu, and CIRC Vice Chairman Chen Wenhui delivered lectures.

#### Xi spoke by telephone with United States President Donald Trump.

Discussed bilateral ties and situation in North Korea.

Xi sent a congratulatory message to the inaugural meeting of China-South Africa High-Level People-to-People Exchange Mechanism held in Pretoria, South Africa.

The meeting decided to further promote the integration of business certifications and licenses into one business license, tackle heavy air pollution, and carry out tests to improve agricultural disaster insurance in major grain-producing provinces.

# Zhang chaired and spoke at the closing meeting of the NPC Standing Committee bimonthly session.

The session approved the revised Surveying and Mapping Law, which was formulated in 1992 and amended in 2002. The session also deliberated a draft law on nuclear safety, draft amendments to the securities law and the standardization law. The session also decided to extend the trial reform of the people's juror system by a year to increase public participation in legal proceedings. The legislature ratified an agreement on border defense cooperation among member states of the Shanghai Cooperation Organization (SCO) and a treaty on exchange of convicted criminals between China and Tajikistan.
